

PRIVACY NOTICE FOR SUPPLIERS

In terms of the provisions of the Federal Law for the Protection of Personal Data in Possession of Individuals (hereinafter referred to as "the Law"), we ask you to carefully read the Terms and Conditions contained in this Privacy Notice prior to the delivery of any personal data or information to us, since the simple provision of your personal data either by physical or electronic means constitutes acceptance of these Terms and Conditions and consequently authorizes us to process and transfer your personal data in the terms expressed below:.

1 Terms and Conditions.

The purpose of this Privacy Notice is to protect your Personal Data by means of which legitimate, controlled and informed treatment of the same will be given, establishing the purposes for which your Personal Data, as defined below, will be used, as well as the mechanisms for the exercise of your rights derived from the Law, in order to guarantee your privacy, as well as your right to informative self-determination.

TKPM as defined below, as responsible for the processing of your Personal Data, is obliged to comply with the principles of legality, consent, information, quality, purpose, loyalty, proportionality and responsibility protected by law; for this reason, based on Articles 13 and 14 of the Law, therefore, TKPM undertakes to make reasonable efforts to limit the period of processing of Personal Data, as well as to keep strict confidentiality of your Personal Data, to maintain administrative, technical and physical security measures to protect them against any damage, loss, theft, alteration, access or unauthorized processing.

For TKPM, the treatment of your Personal Data in a legitimate manner and in accordance with the Law, is a priority issue. This Privacy Notice complements any other simplified or short privacy notices that TKPM has made available to you as the owner of your Personal Data and is supplementary in everything not expressly referred to such notices.

2 Responsible party and address.

The company named THYSSENKRUPP PRESTA DE MÉXICO, S.A. DE C.V., with address at Circuito Esteban de Antuñano number 1, block 4, Ciudad Textil in the city of Huejotzingo, state of Puebla, Z.C. 74160 (hereinafter "TKPM"), will be responsible for the processing, use, storage and disclosure of your personal information whether sensitive or not, such information may include: full name; date of birth, address, gender, copy of official identification with photograph (passport, voter's id); age; company and position held in the same; marital status; nationality; copy of immigration document (if applicable); personal or work email; home, work, cell phone; copy of the federal taxpayer registry; copy of the Unique Population Registry Code (by its acronym in Spanish CURP); commercial references, data for bank transfers (hereinafter Personal Data).

Therefore, TKPM is committed to safeguard your personal information with the highest levels of legal, technological and administrative security. It also undertakes not to sell, rent, share or disclose your personal information to third parties for unlawful purposes.

3. Purposes

By filling out any of our forms, sending via email your Personal Data to TKPM employees and/or by the physical delivery of such information, you accept and authorize TKPM to use and automatically process your Personal Data and information provided, which will be part of our database in connection with the business relationship with TKPM, having the following as primary purposes:

1. To establish contact with TKPM suppliers;
2. The participation in internal bids for the acquisition of goods or services by TKPM.
3. The quotation of goods and/or services whose provision or supply is required for TKPM.
4. The preparation of the corresponding contract or agreement, or if applicable, preparation of purchase orders, as the case may be.
5. To respond to a request or information for the procurement of services or supply of products in favor of TKPM.
6. To process and follow up the services contracted by TKPM.
7. The provision of goods or services that are provided to TKPM.
8. The compliance with the internal policies of TKPM.
9. To maintain updated the legal relationship that exists between you and TKPM.
10. To perform billing, clarifications and payment of consideration.
11. The sending of notifications regarding changes to this Privacy Notice.
12. Sending communications related to suppliers of goods and / or services of TKPM.
13. To meet legal requirements of competent authorities.
14. To comply with the obligations under the commercial or contractual relationship between you and TKPM.
15. To comply with the obligations contracted with customers of TKPM.
16. The attention of doubts and suggestions, as well as evaluation and feedback of the service provided or the good supplied.

Similarly, TKPM may give the corresponding treatment to your Personal Data for the following secondary purposes:

1. Sending information and / or communications related to TKPM.
2. Conduct studies by itself or through third parties for statistical, commercial or internal control purpose.

In case you do not want your Personal Data to be processed for the secondary purposes mentioned above, from this moment you can communicate us the aforementioned, or in your case you have a period of 5 (five) business days to express your refusal for the processing or use of your Personal Data for the secondary purpose mentioned above through the mechanism indicated in section 7 of this Privacy Notice.

It is important to note that TKPM is not responsible for the truthfulness or accuracy of the Personal Data and/or sensitive data that you provide us, since they have not been previously validated and/or verified.

4. Temporality and Collection of Personal Data.

The temporality of the processing of your Personal Data will be for the period of time in which subsists the commercial, contractual or legal relationship between you and TKPM, which may be extended when required by the applicable Mexican Legislation, and you may oppose the handling of the same at any time it deems appropriate according to the mechanism indicated in paragraph 7 of this Privacy Notice, or, as the case may be, when such Personal Data are no longer necessary for the fulfillment of the purposes set forth in paragraph 3 of this Privacy Notice and the applicable legal provisions, for which reason, your Personal Data will be cancelled, thus complying with the provisions of the second paragraph of article 11 of the Law.

TKPM may obtain your Personal Data through the digital environment such as electronic communications that are established with TKPM, during the commercial or contractual relationship, as well as through mail, business cards, telephone communications, filling out physical and/or electronic forms.

TKPM uses various technologies to improve the efficiency of its website <http://www.thyssenkrupp-prestamexico.mx/> (the "Website"), including your experience when you browse the Website. These technologies include the use of cookies. Cookies are small amounts of information that are stored in the browser used by each user so that the server remembers certain information that it can later use. This information allows us to identify you and save your personal preferences in order to provide you with a better browsing experience on the Web Site. We remind you that you can disable or adjust the use of cookies by following the procedures of the Internet browser you use.

5. Transfer of your Personal Data

Therefore, you agree and expressly authorize TKPM to make the transfer of my Personal Data either within or outside the territory of the United States of México to fulfill the purposes set forth in section 3 above established. Similarly, TKPM may transfer Personal Data in the following cases:

1. Third parties derived from a corporate restructuring, including, merger, consolidation, sale, liquidation or transfer of assets.
2. Third party legal service providers in Mexico or abroad that work jointly with TKPM, as well as notaries and public brokers.
3. Commercial recommendations to third parties interested in the goods or services marketed by the holder of the Personal Data.
4. Affiliates and/or subsidiaries of TKPM and its group in the United States of Mexico or abroad.

Third parties and entities receiving the Personal Data, assume the same obligations and/or responsibilities of TKPM as described in this Privacy Notice.

The holder of the Personal Data who submits any request for information or to enter into any type of legal relationship with TKPM expressly agrees to the transfer of their personal data, under the terms described in this Privacy Notice.

Also, we inform you that, for any transfer to third parties, other than those listed above, in terms of the Law we require your consent. If you do not express your refusal for such transfers, it will be understood that you have given it to TKPM. To express your refusal, you must observe the procedure set forth in section 7 of this Privacy Notice.

6. Amendments.

This Privacy Notice may undergo modifications, changes or updates at any time, derived from new legal requirements; from the needs of TKPM's privacy policies and practices; from changes in the business model; or for other reasons. In the event that TKPM would be in the need to make any changes to the Privacy Notice, it will make it known through any of the following means:

1. Notices at TKPM's address.
2. E-mail provided by the owner of the Personal Data.
3. On the website <http://www.thyssenkrupp-prestamexico.mx/>
4. Public Announcements issued by TKPM.
5. Any other means of public or private communication that may be established at the time.

7. Procedure to exercise ARCO rights.

In terms of the provisions of the Law, you have the right to exercise your rights of access, rectification, cancellation and opposition (ARCO) to the processing of your Personal Data, by sending a request via email to: privacidad.prestamexico@thyssenkrupp.com , or in writing to our address located at Circuito Esteban de Antuñano number 1, block 4, Ciudad Textil in Huejotzingo, Puebla Z.C. 74160.

In compliance with Article 29 of the Law, such request must contain the following information:

1. Your name and address or other means of communicating to you the response of your request;
2. Documents proving your identity or, as the case may be, the legal representation of the person making the request on your behalf;
3. The clear and precise description of the Personal Data with respect to which you seek to exercise any of the rights mentioned in the preceding paragraph; and
4. Any other element or document that facilitates the location and identification of your Personal Data.

In case of requesting the rectification of your Personal Data, you must additionally indicate the modifications to be made and provide the necessary official documentation to support your request.

The response to your request will be communicated to you within twenty business days, counted from the effective date on which your request was received, and may be extended for twenty more days in the cases established by Law; in order that, if appropriate, the measures adopted to comply with your request are carried out, which will be carried out within 15 (fifteen) business days following the date on which the corresponding response is communicated.

TKPM may deny access, rectification, cancellation or opposition to the processing of Personal Data, in the following cases:

1. When the applicant is not the owner of the Personal Data, or the legal representative is not duly authorized by the owner of the Personal Data.
2. When in the database of TKPM, the Personal Data of the applicant are not found.
3. When the rights of a third party are harmed.
4. When there is a legal impediment, or the resolution of a competent authority, which restricts the access to the Personal Data, or does not allow the rectification, cancellation or opposition thereof.
5. When such ARCO rights have been previously exercised by the owner of the Personal Data or its representatives.

8. Revocation of Consent.

You may revoke your consent to the processing of your Personal Data. However, it is important to note that not in all cases TKPM will be able to meet your request or terminate the use immediately, since it is possible that for some legal obligation TKPM requires to continue processing your Personal Data. Also, you should consider that, for certain purposes, the revocation of your consent will imply the conclusion of the business relationship with TKPM. To revoke your consent, you must submit your request in the terms contained in section 7 of this Privacy Notice.

We inform you that any complaint or additional information regarding the treatment of your Personal Data or any doubt in relation to the Law, you may address it to the National Institute of Transparency, Access to Information and Protection of Personal Data (by its acronym in Spanish “INAI”).
